

RESIDENTIAL PROPERTIES

State 1% permit fee

Pursuant to 3781.102(F)(2) of the Ohio Revised Code all residential permit fees shall be charged an additional State 1%.

Manufactured Home Seal

Pursuant to Chapter 4781 of the Ohio Revised Code the manufactured homes commission has established the rate for the manufactured home seal..... \$75.00/seal

Total Square feet (s.f.) is based on but not limited to: decks, porches, garages, basements, living area, etc.

<u>Dwellings</u> (less than or equal to 3,000 total square feet).....	\$250.00 Base
<u>Dwellings</u> (greater than 3,000 total square feet).....	\$250.00 + .03/s.f.
<u>Duplexes</u>	\$300.00 + .03/s.f.
<u>Triplexes</u>	\$350.00 + .03/s.f.
<u>Foundations Only</u>	\$100.00 Base

Manufactured Homes/Industrial Units

(less than or equal to 3,000 total square feet) \$200.00 Base

(greater than 3,000 total square feet) \$200.00 + .03/s.f.

Special Inspection for Manufactured Homes/Industrial Units older than 1976 \$50.00 Base

Addition /Attached Garage to Manufactured Home/Industrial Unit - (When constructed at the same time the manufactured home/industrial unit is installed.) \$50.00 + .03/s.f.

Additions (less than or equal to 1,000 total square feet)..... \$200.00 Base

Additions (greater than 1,000 total square feet)..... \$200.00 + .03/s.f.

Additions / Alteration / Change of Use with existing foundations

(less than or equal to 1,000 total square feet) \$150.00 Base

Additions / Alteration / Change of Use with existing foundations

(greater than 1,000 total square feet) \$150.00 + .03/s.f.

Detached Garages/Accessory Buildings/additions to detached garages and accessory buildings/sleeping cabins only with no kitchens, restrooms, insulation or drywall.

(less than or equal to 1,000 total square feet) \$150.00 Base

Detached Garages/Accessory Buildings/ additions to detached garages and accessory buildings/sleeping cabins only with no kitchens, restrooms, insulation or drywall.

(greater than 1,000 total square feet) \$150.00 + .03/s.f.

Smaller projects requiring only two inspections such as the following:

Decks / Open Porches with Roofs / Three Season Additions with no heat, drywall or insulation / Metal Car Ports / Gazebos / Pavilions/ Roof Over Trailers / New Roofs on existing structures / Unheated Utility Rooms/Enclosed Porches with no drywall/ Reroofing on existing dwelling / Metal detached buildings without foundations and less than 400 s.f..... \$100.00 Base

(A reinspection shall be required when the inspector must return to work that was not ready, building was locked or had failed a previous inspection.)

Stop Work Order Double permit fees

Electrical Registration, Test/ Residential licensing, and/or Renewal \$50.00 per each

Refundable Deposit \$0.25 per total s.f.
(\$100 minimum, \$500 maximum)

EXEMPTION to Refundable Deposit: Smaller projects requiring only two inspections such as the following: Decks / Open Porches with Roofs / Three Season Additions with no heat, drywall or insulation / Metal Car Ports / Gazebos / Pavilions/ Roof Over Trailers / New Roofs on existing structures / Unheated Utility Rooms/Enclosed Porches with no drywall/ Reroofing on existing dwelling / Metal detached buildings without foundations and less than 400 s.f are exempt from the required refundable deposit.

If not paid, reinspection and permit renewals fees shall be deducted from the refundable deposit prior to refunding the deposit.

NOTE: Contractors have the option of placing a one-time \$1,500 refundable deposit to cover all proposed residential projects. This one-time deposit is not refundable until all projects have been inspected and finalized.

Permit Renewal (each permit renewal is good for one year) \$100.00 Base

NOTE: Permits shall be valid for two years. Construction shall commence within twelve months of issuance date. One free six month extension shall be given provided contractor/applicant/owner notifies the Building Department prior to expiration date.

NOTE: \$40.00 administration fee shall be deducted for all cancelled permits prior to construction.

Permit Exceptions Note: Decks less than 30" from finish grade, accessory to the main structure and less than 200 s.f. (Or, as modified by the Residential Code of Ohio), do not require a building permit. Window replacements and re-shingling with no structural changes do not require a building permit. Shingling over two layers is not permitted. Accessory buildings under 200 s.f. (Or, as modified by the Residential Code of Ohio) do not require a building permit. All agricultural buildings as defined by the Ohio Revised Code do not require a building permit, provided a letter is submitted by the property owner with a copy of the zoning certificate indicating that the proposed use is agricultural.

Board of Building Appeals \$100.00 Base

Permit fees for contracted projects not located in Ashtabula County shall be doubled.

COMMERCIAL PROPERTIES

State 3% percent fee

Pursuant to 3781.102(F)(1) of the Ohio Revised Code all commercial permits and plan reviews shall be charged an additional State 3%.

Plan Review Fees - All plan review fees are charged at the rate of \$85.00 per hour. Consultation with the plans examiner are charged at \$85.00 per hour.

Hood & Suppression (when done by the same company) \$100.00 Base

Stop Work Orders Double Permit Fees

Contractor Registration and/or Renewal \$50.00 Base

NOTE: Balance of all permit fees and plan review fees shall be paid prior to issuance of a building permit.

NOTE: \$40.00 administration, any inspections performed plus all plan review fees shall be deducted for all cancelled permits prior to construction.
